

**1. The Promoter**

The promoter is: The City of York Council of West Offices, Station Rise, York.

**2. The competition**

2.1 The title of the competition is **“Win tickets to see Sleeping Beauty”**

**3. How to enter**

3.1 The competition will run from Saturday December 7 2019 (the **“Opening Date”**) to 23:59 on Sunday 5 January 2020 (the **“Closing Date”**) inclusive.

3.2 All competition entries must be received by the Promoter by no later than 23:59 on Sunday 5 January 2020. All competition entries received after the Closing Date are automatically disqualified. The winner will be contacted by 17:00 on Wednesday 8 January 2020.

3.3 To enter the competition:

- (a) email your answer to the below question, plus your name, address and contact number to our.city@york.gov.uk by the Closing Date;

***What did Sleeping Beauty prick her finger on before falling into a deep sleep?***

3.4 The Promoter will **not** accept:

- (a) responsibility for competition entries that are lost, mislaid, damaged or delayed in transit, regardless of cause including for example, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind: or
- (b) proof of posting or transmission as proof of receipt of entry to the competition.

3.5 By submitting a competition entry, you are agreeing to be bound by these terms and conditions.

3.6 Winners will be drawn at random from valid entries received on the Tuesday 7 January 2020 (the **“Announcement Date”**).

**4. Eligibility**

4.1 The competition is only open to all residents of York. If you are under the age of 18, you must obtain written parental or guardian consent to enter and claim your prize. The Promoter may ask the winner to provide proof of age.

4.2 In entering the competition, you confirm that you are eligible to do so and eligible to claim any prize you may win. The Promoter may require you to provide proof that you are eligible to enter the competition.

4.3 The Promoter will not accept competition entries that are:

- (a) automatically generated by computer;
- (b) completed by third parties or in bulk;
- (c) illegible, have been altered, reconstructed, forged or tampered with;
- (d) incomplete.

4.4 The Promoter reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize competition.

4.5 There is a limit of one entry to the competition per person.

## **5. The prize**

5.1 The prize is a group ticket for 4 people for a showing of Sleeping Beauty at York Theatre Royal, St Leonard's Place, York YO1 7HD. Tickets are subject to availability and will only be available for a Monday – Thursday performance during January, for use before 25 Jan 2020. There is no cash alternative for the prize.

5.2 The prize is not negotiable or transferable.

## **6. Winner announcement**

6.1 The decision of the Promoter is final and no correspondence or discussion will be entered into.

6.2 The Promoter will contact the winner personally as soon as practicable after the Announcement Date, using the contact information provided with the competition entry

## **7. Claiming the prize**

7.1 The Promoter will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available, or has not claimed their prize within five working days of the Announcement Date, the Promoter reserves the right to offer the prize to the next eligible entrant selected from the entries that were received before the Closing Date.

7.2 The Promoter does not accept any responsibility if you are not able to take up the prize.

**8. Limitation of liability**

Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.

**9. Data protection and publicity**

9.1 The Promoter will only process your personal information for the purposes of selecting and contacting the competition winner and allowing prizes to be claimed.
