**STREET TRADING CONSENTS - CAR BOOT SALES**

**LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT 1982**

**GENERAL INFORMATION**

1. A street trading consent is required by the organiser of a car boot sale where the sale is held in a place to which the public have access without payment.
2. A consent will be issued to the organiser who will hold the consent for all traders. Relevant fees can be found on the City of York Council website and are categorised as follows  
  
Less than 15 traders  
15 - 50 traders  
51 - 100 traders  
More than 100 traders  
Charities/non profit making organisations/schools
3. If the organiser is unsure of the number of traders who will attend the fees can be adjusted after the event.
4. No consent will be issued where trading is carried out by market traders and no trader should engage in the buying of new goods for sale.
5. If any professional trader is invited to attend (e.g. mobile catering vans) they must seek a consent in their own right.
6. Any person engaged in trading without a valid Consent or contrary to the terms of any Consent shall be liable on summary conviction to a fine not exceeding £1,000.
7. It is an offence for the applicant to make any false statement in the application.
8. Licences will not be issued until the appropriate fee is paid.
9. The application should be completed clearly in ink and block capitals.
10. Any person who holds a car boot sale in the City of York Council area or allows their premises to be used for such purposes must register under the North York County Council Act 1991. Please seek further information from North Yorkshire County Council.
