If different trading units are used at different times of the year details of all trading units must be provided.
4. A copy of the Public Liability Insurance Certificate giving at least £5,000,000 cover will be required before trading commences.
5. Name and address details of any assistant(s) who work on the stall/trading unit will be required before trading commences.
6. If you wish to trade on private land, written confirmation that you have the landowner's permission.
