I've now had chance to read through the draft SCG. This is tricky as it has yet to be signed and therefore the reference to the Site Allocations Local Plan should probably be updated as I would imagine this will be picked up by the Inspectors?

Are you proposing to seek signatures from Members in the same way as we did for the LCR SCG?

Further to our correspondence earlier this week I've spoken with Cllr Musgrave our Lead Executive Member for Place Shaping and he's agreed that we can agree the following response:-

"As Selby District Council are at a very early stage in the preparation of the Local Plan we are yet to establish how we will accommodate growth in the District however it would be our intention to meet our own needs within our administrative boundary. We will continue to work positively with City of York Council on any emerging cross boundary strategic matters including future housing requirements as we progress the Local Plan"?

I just wonder whether it would be helpful to add something along these lines to the SCG to try and round off this issue at an early stage?
